Week ending May 31, 2024

In a light week of economic releases, corporate earnings were the driver behind the market's negative performance this week, but all three indices managed to post positive returns for the month. Friday's release of the Personal Consumption Expenditures (PCE) Price Index was in line with expectations with a gain of 0.3% for the month and 2.7% on a year over year (YoY) basis. The Core PCE, which excludes food and energy, came in below expectations with a gain of 0.2%.

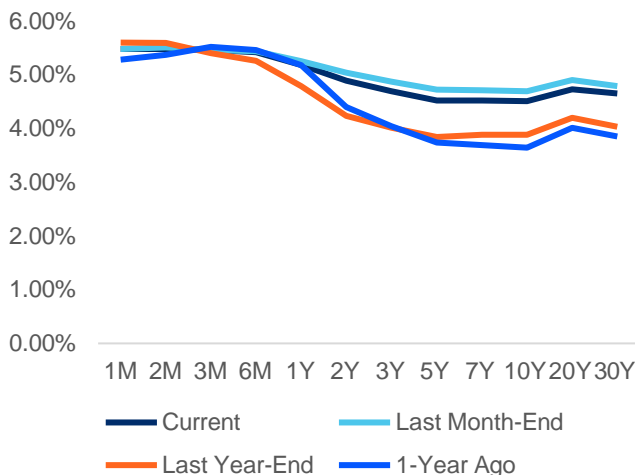
Fixed Income Markets Overview

- Bonds were relatively flat for the week as investors had no change in their rate forecasts following the PCE release.
- Housing data this week continues to show increasing prices across the U.S. as the S&P Core Logic Case-Shiller 20 City Composite Price Index reported a YoY increase of 7.4% as of March 2024, the highest level since 2022. San Diego saw the largest price gain, followed by New York and Cleveland.
- Higher home prices along with elevated mortgage rates continue to put pressure on real estate sales with April pending home sales dropping below expectations with a decline of 7.7%.

Equity Markets Overview

- As mentioned, all three equity indices were down for the week with the Nasdaq seeing the largest decline of 1.1%. For the month of May all three indices were higher with the S&P up by 4.8%, the DJIA up by 1.5%, and the Nasdaq with a gain of 6.9%.
- There were mixed signs in the retail sector last week with earnings from Foot Locker and the Gap beating analysts' estimates, but Kohls, Nordstrom, and Ulta Beauty falling below expectations. Other key earnings reports included disappointing results from Salesforce, Marvell Technologies, and Dell Computer.
- With 98% of the S&P 500 companies having reported first quarter earnings, FactSet is reporting an earnings growth rate of 5.9%. 78% of the reporting companies have announced positive earnings surprises, while 61% have reported positive revenue surprises.

Alternative Markets Overview

- The price of oil was down for the month of May. OPEC+ is scheduled to meet this week and analysts are watching to see if the group will extend production cuts.
- Silver outperformed gold in May, up by almost 14% while gold was relatively flat despite reaching a new high mid-month. For the year to date, silver has seen a gain of over 27%, while gold is up 13.2%.
- Bitcoin also showed positive returns for the month, up by 11%. Ethereum has seen a 31% gain thanks in part to SEC approval for spot ETFs.

- Friday will be the all-important May Jobs report. Current expectations are looking for an increase of 185,000 jobs for the month, a slight increase over April's level.

Bloomberg Barclays U.S. Aggregate Bond Index represents securities that are SEC-registered, taxable, and dollar denominated. The index covers the U.S. investment grade fixed rate bond market, with index components for government and corporate securities, mortgage pass-through securities, and asset-backed securities.

Bloomberg Barclays U.S. Treasury Aggregate Bond Index is the U.S. Treasury component of the U.S. Government index and represents public obligations of the U.S. Treasury with a remaining maturity of one year or more.

Bloomberg US TIPS Index consists of Inflation-Protection securities issued by the U.S. Treasury.

Bloomberg Barclays US Corporate Bond Index is the Corporate component of the U.S. Credit index and represents publicly issued U.S. corporate and specified foreign debentures and secured notes that meet the specified maturity, liquidity, and quality requirements.

Bloomberg Barclays U.S. Corporate High Yield Index covers the universe of fixed rate, non-investment grade debt.

Bloomberg Barclays Emerging Markets Bond Index is broad-based with country eligibility and classification as an Emerging Market being rules-based and reviewed on an annual basis using World Bank income group and International Monetary Fund (IMF) country classifications.

Bloomberg Barclays U.S. Municipal Index is a rules-based, market-value-weighted index engineered for the long-term tax-exempt bond market.

Bloomberg Barclays US High Yield Municipal Index is an unmanaged index of noninvestment-grade municipal debt securities, which provides a representation of the performance of US high-yield tax-exempt bonds.
